INSTRUCTIONS FOR AUTHORS

The Manuscript Studies (StR) Editorial Board requests authors to comply with the following principles when submitting contributions:

- Please submit texts in digital format as DOC or RTF files. Unless agreed otherwise with the Editorial Board, articles should not exceed 30 standard pages (1 standard page = 1,800 characters including spaces).
- Image attachments are accepted in digital form with sufficient resolution (at least 300 dpi) in one of the common formats (tif, jpg) in separate files. We recommend that you consult the Editorial Board individually over the way in which this material is to be delivered. The authors are responsible for obtaining copyright and reproduction rights to the attached illustrations.
- Articles are to be accompanied by an English abstract of no more than 800 characters, keywords in English, and a summary in German or French (approx. one standard page). The materials for an abstract and summary may also be sent in Czech.
- The authors have the right to authorial editing; no substantial changes are permitted in the text during editing without the consent of the Editorial Board.
- The authors are fully responsible for the correctness of the content and the linguistic standard of the manuscript. The Editorial Board reserves the right to make editorial alterations with the agreement of the author.
- No fees are paid for contributions to StR. The author is to receive one copy of StR and an offprint (pdf).

- Please keep layout and text formatting to a minimum. Use the following style: basic or normal text; font: Times New Roman, 12 points, spacing: 1.5; footnotes: 10 points, spacing: 1.
- Avoid dividing words and do not align the text. Enter footnotes using References > Insert Footnote. Always place the note number after punctuation.
- Please distinguish between a dash (–) and a hyphen (-). When indicating a range, use a dash without spaces: October–April, 9–16; pages: 16–24; years: 1841–1904; use a dash with spaces for multi-word names: Praha 1 – Malá Strana. The hyphen is utilised for compounds expressing duality or reciprocity (Frýdek-Místek, Czech-German dictionary, Anna Císařová-Kolářová).
- Years and volumes of periodicals are to be expressed in Arabic numerals, while individual parts of multi-volume works and editorial series are to be written in Roman numerals. If documents in the editorial series are numbered, the respective pages are to be complemented by this number.
- For references, use the abbreviation ‘cf.’, for page(s) the abbreviations ‘p.’ or ‘pp.’, for a footnote ‘Note’.
- All the issues of MS contain a list of the abbreviations used. The names of journals, editorial series and institutions (archives, libraries, etc.) should be given under commonly used abbreviations. The authors are kindly requested to include a list of the abbreviations.

Recommendations for Editing the Main Text

- The titles of books, journals, studies, etc. in the main text should be in **italics**. The same rule applies to quotations of Latin expressions and quotations of Latin text. In this case, the quotation is **without inverted commas**!
- Quotations of non-Latin text should be **in inverted commas without italics**. Use double inverted commas ("") only for a quotation within a quotation in single inverted commas ("").
- An ellipsis is to be indicated by a set of three evenly spaced dots (shortcut Alt + 0133) in square brackets [...].
- For personal names cited in the main text, include the full name in the first occurrence; in subsequent occurrences, write the first and middle names using initials. In the first occurrence of institutions, write their full names followed by the abbreviations in round brackets if they occur again in the text below.
- Highlight words **in bold**.

In the first occurrence, give the full name of the place of deposit and the collection; abbreviate the name in subsequent occurrences.

Electronic Information Resources

When citing from a website, give the author's name, the text title, the type of medium ([online]/[CD-ROM]/[disk]), the website owner, the date on which the website was accessed (ideally, the date of the last update of the website) and the URL (for online documents).
